In view of recent events where hundreds of transiting Overseas Filipino Workers (OFWs) and Returning Overseas Filipinos (ROFs) mostly from Kuwait and the Kingdom of Saudi Arabia, as well as UAE-based OFWs and ROFs, were offloaded and stranded due to the ongoing restrictions/quotas imposed by the IATF among incoming international carriers, all traveling Filipinos with flights back to the Philippines are strongly urged to closely coordinate with their respective airlines, for any development regarding their flight confirmation and quarantine facility in transiting country, if needed.

Contrary to the proviso from travel agencies and/or airlines requiring hotel booking and Overseas Employment Certificates prior to flight for OFWs, please be advised that the Philippine government, thru the Overseas Workers Welfare Administration (OWWA), will still cover the facility-based quarantine and swab-testing of all OFWs. On the other hand, OEC is required only at the point of exit of returning OFWs to the jobsite, and not at the point of exit going back to the Philippines. It serves as an exit clearance/pass and exempts them from travel tax and airport terminal fee.

Upon arrival in the Philippines, OFWs shall need to present any of the following as proof of their status: employment contract, OEC, payslip, OWWA membership and valid company ID. Moreover, as facility-based quarantines are in full capacity, OWWA requests for all arriving Filipinos' understanding as they can expect a waiting period before they can be assigned to a quarantine hotel.

The following testing and quarantine protocols shall be observed for arriving Filipino passengers to the Philippines per IATF Resolution No. 154-C, Series of 2021, dated 14 December 2021:
